MT-003	VENDOR FACILITY ACCESS	The right of access by the organization, their customer, and regulatory authorities to the applicable areas of facilities and to applicable documented information, at any level of the supply chain.
MT-004	SUB-CONTRACTOR PRE-APPROVAL	If Vendor Plans on Using Sub-Contracting Work, MT Must Approve.
MT-005	SUB-TIER FLOW DOWN	Vendor Must Flow Down Requirements to Sub-Tier Vendors Including Key Characteristics Where Applicable.
MT-006	SUBJECT TO SOURCE INSPECTION	MT or Its Customer May Require a Source Inspection Prior To Shipment of Product.
MT-007	RECORD RETENTION CLAUSE	Vendor Must Maintain Records Related to this Purchase Order for 10 Years Unless Otherwise Stated By Purchase Order.

Vendor Will Legibly Identify and Record the Cage Code on Vendor's Shipping Documentation and Applicable Certification Documents. If The Manufacturer Does Not Have a Cage Code, Vendor will so annotate the Shipper and Certifications.

MT-023	SUPPLIER AWARENESS OF PRODUCT SAFETY	Supplier furnished parts and components will be incorporated into articles intended for aerospace and defense application.
